It is further recommended that the fine be increased to **\$300.00** per day for each day the violations are repeated after March 26, 2015.

The December 4, 2014 meeting was rescheduled by Staff to December 18, 2014. At the request of the Respondent's attorney, the Board continued the hearing to January 22, 2014.

On March 23, 2015, the Inspector filed a Notice of Voluntary Dismissal Without Prejudice for the violation of "occupying the structure without an approved Certificate of Occupancy at 910, 920 and 930 Britt Court" only.
